The cause of action for the event that occurred at the library puts this matter upon the hearing of the Library Board of Trustees on July 13th 2021.

This matter, considering my history of performing work effort provided as a former staff of the library is extremely insulting and actually an offense that is a violation of the law and must be deemed discrimination -- and I am not going to just drop this.

The decision and posting of public notice [attached] reflect something sinister in the events that happened.

A 6 Month suspension of library access and use of public services without notice of such public hearing to provide the actual truth to what occurred.

To who and what violated normal customs and violated the law first was your staff.

The police were legally required to enforce a transfer of your orders that I would then have to obey to leave.

The action of the police officer to respond to my act of calling the police,

The pinned reason that I already can conceive to realize would be the result more than possible - Escapism probable.

The officer failed to bring the mission of the San Bernardino Police of excellence --- PROTECT and SERVE into his duty.

The police officer abandoned the public duty to serve the law and upon the request for verbal disorder actually violated civil laws.

Upon his arrival, had acted to a personal choice to abandon the scene and the documentation of the event.

I was not given a FAIR WARNING!

Why did the officer take his personal action to not engage in the incident in a legal means?

The officer that responded to my call -- Arrived to park at the curb on the street.

As he was exiting his vehicle, he indeed recognized me.

I placed a reminder into a spoken calling out to him my name and a reminder to the motel events that occurred in January.

Already predicted --

The on-duty officer that was responding to a citizen's dispatch, the responding officer abandoned his duty this now June interface to the police to the needed legal process. Failing to respond to my need to collect a report and hold a true order of trespass. I knew that whoever would be the dispatched officer that would respond to this request, most likely would not maintain their professional duty.

Guidelines to Issuing Trespass Warnings

The most important details about trespass warnings are:

- 1. They are issued directly to the person being trespassed
- 2. They are specific as to trespassed location and enforceable time period
- 3. It can be verified that the warning was given and that verification can be presented in court, in the event the person pleads "not guilty" to the charge

A verbal warning may be given, but a written warning is more likely to be prosecuted. Again, the point is to be able to prove in court that the person was

given fair warning.

Enforceable trespass notices can be established in several ways:

- 1. If an officer is already on scene and in contact with the offending individual, at your request, the officer can verbally inform the person they are trespassed; the officer then makes note of that warning here at the police department, and should give you the case number, that way the documented warning can be located again in order to issue a ticket to the same person later, should they violate the warning
- 2. You may hand-deliver a written trespass notice directly to the person, or send it by certified mail (return notice requested, for delivery verification); you should have a duplicate saved for your records, and send a copy to the police department for our files
- 3. You may give someone a verbal notice, but this is the least effective method; if you choose this, it is recommend that you have a witness who you can produce in court, and also reduce the notice and service date to writing in your own records

ANSWER

Bearing false witness is mentioned many times in the Bible, exclusively as something bad. "You shall not bear false witness against your neighbor" is the ninth of the Ten Commandments that Moses brought back with him from his encounter with God on Mount Sinai (Exodus 20:16). False witness, or spreading a false report, is associated with being allied with the wicked (Exodus 23:1), willing to do violence to others (Psalm 27:12), and sowing discord among brothers (Proverbs 6:19). The Bible calls bearing false witness lying (Proverbs 14:5) and compares a man who bears false witness against his neighbor to a violent weapon (Proverbs 25:18). Lies harm people.

A false witness is one who stands up and swears before others that something untrue is true, especially with the intention of hurting someone else or ruining his reputation. This happened to David (Psalm 27:12), Jesus (Matthew 26:60; Mark 14:56), and Stephen (Acts 6:13). When the wicked Queen Jezebel wished to procure a vineyard for her sulking husband, King Ahab, she employed two false witnesses. Naboth, the rightful owner of the vineyard, was seated in an honorable place on a day of fasting, but "then two scoundrels came and sat opposite him and brought charges against Naboth before the people, saying, 'Naboth has cursed both God and the king.' So they took him outside the city and stoned him to death" (1 Kings 21:13). What the "scoundrels" said against Naboth was absolutely untrue; they were bearing false witness with impunity and with the queen's blessing. As a result, an innocent man was killed. When a person is righteous and his enemies can find nothing with which to blame him, bearing false witness is a common weapon.

The lies told by a false witness come from the sinful human heart—along with murder, adultery, sexual immorality, theft, slander, and evil thoughts (Matthew 15:19). Jesus said that man is defiled by these evil things that come from the heart. The only possible cure for an evil heart that bears false witness is to receive a new, pure heart, which can only be given by God (Ezekiel 36:26). When a person is indwelt by the Holy Spirit, he will be like a fresh spring or a fruitful tree or a budding vine, bursting with good things (John 7:38; Psalm 1:1–6; John 15:4–5). The old is gone, and the new takes its place (Ephesians 4:22–24). Those who are in Christ have a new heart that speaks the truth: "Each of you must put off falsehood and speak truthfully to your neighbor" (Ephesians 4:25). A person who bears false witness is controlled by the flesh rather than by the Spirit of God, and he should repent of that sin and turn to Christ.

"There are six things that the Lord hates, seven that are an abomination to Him...a lying tongue...a false witness who breathes out lies..." (Proverbs 6:16–19).

Desk Manager (Cosand Computer Center)

Maintained library patrons walk-in use of computer lab. Full implementation of information databases including user's file, software catalog, and lab users login interface. Reservations could be made up to two months in advance and computer time was restricted to two hours per day. The lab's desk manager maintained currently logged in users, remaining time, and any checked out software materials being used at the workstations. Lab administrators could schedule class or other group reservations, as needed. Statistical usage information was reported.

Microlink BBS (Public Library online bulletin board system)

Full development of user login database, public and private messaging, questions to reference librarians, information bulletins, online games, usage log and statistics features. First online in 1983 using a \$5000 Corvus 10mb hard drive and a Hayes 300bps Micromodem. No commercial BBS software packages existed for this type of application. Microlink BBS was the second public library in the country to offer such dial up services next to The Chicago Public Library. Microlink was later renamed to LOLA (Library On-Line Apple).
